Owner-Builder Declaration

I hereby affirm under penalty that I am exempt from the Contractors License Law for the following reason Sec. 7031.5 Business & Professions Code. Any city or county which requires a permit to construct, alter, improve, demolish or repair any structure, prior to its issuance, also requires the applicant for such permit file a signed statement that he or she is licensed pursuant to the provisions of the Contractor's License Law (Chapter 9 (commencing with Section 7000) of Division 3 of the Business and Professions Code) of that he or she is exempt therefrom and the basis for the alleged exemption. Any violation of Section 7031.5 by any applicant for a permit subjects the applicant to a civil penalty of not more than five hundred dollars (\$500).

A) I, as owner of the property, or my employees with wages as their sole compensation, will do the work, and the structure is not intended or offered for sale (Sec. 7044, Business and Professions Code: The Contractor's License Law does not apply to an owner of property who builds or improves thereon, and who does such work himself or herself or through his or her own employees, provided that such improvements are not intended or offered for sale. If however, the building or improvement is sold within one year of completion, the owner-builder will have the burden of providing that he or she did not build or improve for the purpose of sale).

B) I, as owner of the property, am exclusively contracting with licensed contractors to construct the project (Sec. 7044, Business and Professions Code: The Contractor's License Law does not apply to an owner of property who builds or improves thereon, and who contracts for such projects with contractor(s) licensed pursuant to the Contractor's License Law).

Owner-Builder to perform and the structure is intended or offered for sale. In order to be exempt under Business and Professional Code Subsection 7C44(C) where an Owner-Builder intends to perform work and the structure is intended or offered for sale, the applicant must comply with the following conditions: 1. The structure is his or her principal place of residence. 2. He or she has resided in the residence for the 12 months prior to completion of the work. 3. He or she had not availed his or herself of this exemption on more than two structures more than once during any three-year period.
